

# **Security Doors and Windows**

The estate permits the installation of security doors and windows.

It is important to note that in the past it was permitted to install the 10 mm square Galvanised Mild Steel Burglar Guard Bars (Spaced at 160mm apart) on windows and doors.

However, with the resolution of both the aluminium and insect screens on windows and doors the estate will also accept installation of a security mesh which comply with the below specifications:

The following specifications apply:

- 1) 0.9 mm diameter 304 or 316 stainless steel interwoven mesh
- 2) Powder coated to avoid any corrosion (Aluminium frame to be brown in colour /bronze as known by the industry)
- 3) Heavy-duty 304 stainless steel


Owners may use a combination of the bars and the mesh provided the frame and bars are changed to the required aluminium spec and complies with the 10 mm bars design.

All doors and windows are to comply with the brown(bronze) powder coated finish that match the rest of the estate. (No other colours such as white or black will be permitted)

Kindly Note: Balconies may not be enclosed in any way or form.
